Legislative Update by Lobbyist Jim Hirst

Since the start of the legislative session in January, MDRA with the direct involvement of our members and allied partners, has worked to draw renewed attention with our lawmakers of the critical need to address our inadequate filing fees that remain woefully insufficient to cover our operations. Our situation has now become even more dire after enduring a full year of COVID restrictions and expenses, not to mention a conversion to MNDRIVE that has transferred additional workloads to our staff and increased demands for DL services.

Last month we completed our annual time and motion studies with Winona State University, which not surprisingly, confirmed that all categories for motor vehicle and driver license transactions continue to trend upward in time required for the past three years now. The study also revealed rising rates of no-fee and incomplete transactions, as well as other uncompensated activities such as time spent responding to emails and phone calls answering questions from the public. These latest studies have been shared with legislative leaders to bolster our arguments. Thank you to the many offices who participated in the data collection for this annual effort, especially amid such trying times.

Recently we received a request from lawmakers for profit/loss summaries from offices. MDRA lobbyist Jim Hirst is collecting this data alone and will keep all submissions confidential and destroy them after compiling the data. He is composing an overall summary with no identifying characteristics and is breaking down the data into overall small/medium/large office categories only. To date he has received data from 28 offices (both public and private) yet seeks more. Please submit to him a basic balance sheet with your bottom-line reflecting years 2020 and 2019. Please also notate any state MNLARS compensation received in 2019 and any PPP loans obtained in 2020 as these need to be factored out so they don't skew the true financial picture. Despite our collective efforts to date, the legislature has been hesitant to hear our filing fee legislation introduced months ago. The legislature has entertained hearing deputy kiosk legislation though, which will be a helpful component eventually for offices who choose to pursue it. However, that alone won't satisfy our immediate and long-term needs for fiscal relief and sustainability.

Chair Scott Newman of the Senate Transportation Committee has now created his omnibus transportation bill which incorporates the kiosk language. However, in recognition of our overall fiscal situation he included a provision in his bill whereby DVS must compensate all deputies based on their completed motor vehicle and driver license transactions on a quarterly basis. This "rebate" would amount to an additional \$2 for each renewal, \$3 for each long app, and \$3 for each DL. It would keep existing filing fee rates without change and a fiscal analysis showed an additional \$12 million annually to the deputy network with this proposal. MDRA has signaled its support for this novel alternative in the absence of any filing fee increases from the Senate. In recognition of the DVS transfer of workloads to deputies, there is certainly some merit in this approach.

Meanwhile, Chair Frank Hornstein of the House Transportation Committee has likewise started to construct his omnibus transportation bill which also includes kiosk language, but nothing on filing fees. Our champion and author of our fee bill in that body, Representative Steve Elkins, prepared a "hybrid" version of the Senate approach for the House to consider adding to their omnibus bill. It combines both rebate language with lower filing fee increases. It received preliminary bipartisan support last week in committee discussion upon presentation. However, it lacked the official fiscal analysis which caused its formal adoption to be deferred. Preliminary estimates suggested it could raise \$16 million annually for the deputy network of which \$2 million would be borne by DVS rebates. Chair Hornstein stated he would await the official fiscal analysis but would use this hybrid language as the framework for a House position to negotiate with the Senate when the differing House and Senate omnibus transportation bills are conferred and crafted into one later in session.

Our efforts and voices are being heard! However, in these closing weeks of session, please reenergize your efforts in routinely contacting your legislators and stress the importance of enacting meaningful financial support for deputy registrars this year! Remember to cite your own difficulties and ongoing losses affecting not only you and your staff, but on your customers depending on your services as well. It is critical that we keep up the legislative progress we've made to date and not falter in the end!

Thank you, deputies, for your ongoing hard work in these difficult and challenging times, and for this critical participation asked of you in these closing weeks of session.



DVS Update by Beckey Mechtel

Deputy registrars and driver's license agents help the Minnesota Department of Public Safety Driver and Vehicle Services division (DPS-DVS) serve customers in every corner of our state. That partnership is vital to customers. DPS-DVS is working to find new ways to deliver service, especially in light of the COVID-19 pandemic. Online services have and will continue to play a key role in service delivery models. DPS-DVS wants to continue working together with deputy registrars and driver's license agents to find innovative solutions to provide services while protecting the safety and health of our customers and employees.

DPS-DVS continues to put the customer first by focusing on strategies to serve customers and business partners faster and more efficiently.

○ Pre-verification project.

Document pre-verification began March 29. The process allows customers to upload their proof of identity and residency documents for DPS-DVS staff to review and verify. DPS-DVS then emails the customer pre-verification to bring to the office to complete their application. This reduces processing times. If the documents aren't acceptable, the customer has the opportunity to upload new document images.

Since it launched, more than 2,000 customers uploaded proof of identity and residency documents for pre-verification. DVS saved potentially 1,800 customers an extra office visit.

MNDRIVE Phase II.

The second phase of MNDRIVE is scheduled to go live October 2021. This phase focuses on motor carriers and international registration plan (IRP) and international fuel tax agreement (IFTA) administration. Some of the new features include:

The ability for motor carriers to upload documents.

Online pre-application for new IRP and IFTA accounts.

Obtain IFTA decals.

The ability to add and delete vehicles from accounts.

Motor carrier community representatives and prorate deputy registrars are serving as subject matter experts and project testers.

MNDRIVE Enhancements and Fixes.

DPS-DVS and FAST teams continue creating enhancements and fixes to improve the customer and business partner MNDRIVE experience. The MNDRIVE team works with deputy registrar and driver's license agent representatives to prioritize requests for changes or enhancements. Known issues are in the MNDRIVE help manager.

Email the motor vehicle liaisons at dvs.mv.businessliaisons@state.mn.us to add a known issue to the list. Please put "Known Issues" in the subject line of your email.

You can use the help manager to submit requests for future system enhancements. In the help manager:

Go to "I Want To" tab.

Select "Deputy Registrar Priority Request."

Submit suggestion for change or future enhancement.

Taking advantage of training opportunities, sharing ideas and staying informed are important parts of delivering the quality services our customers need and expect. DPS-DVS leadership hosts monthly digital information meetings and encourages office managers and appointees to attend. 




